Consultative Meet on Maharashtra's Investment for Women and Children

Venue: Management Council Room, Mumbai University, Fort, Mumbai

Date: April 25, 2023

Concept Note

Maharashtra budget 2023-24 comes at a time when the state has almost recovered from the crises caused due to the COVID-19 pandemic. However, there are growing concerns around high inflation and rising inequality. For instance, female labour force participation rate (39%) and sex ratio at birth (881) are low for the state, and undernutrition levels are high (35.2% children in the state are stunted). Additionally, the state has witnessed significant political changes last year, leading to formation of new government in June. All these socio-economic-political changes have impacted the people in the state, especially the marginalised women and children. While steps have been taken to improve lives of women and children in the state, such as drafting of the state's gender and child policy, budgetary announcement for women empowerment (such as Lek ladki, concession on bus travel, etc.), there is still scope for gender transformative and child responsive initiatives. In this context, it is important to assess budgetary provisions and policy directions related to some of the core areas such as health, education, employment and also evaluate the responsiveness of the state budget to the rights and development needs of women and children.

Over the past few years, UNICEF has been working with the GoM on Public Finance Management for Women and Children; the partnership has undertaken sensitisation of departments on gender and child needs, publication of gender and child budget statements (GBS and CBS), etc. The state has established an Outcome cell, within Department of Finance to carry forward these initiatives. Also, UNICEF has an institutional arrangement with the Mumbai School of Economics and Public Policy (MSEPP), University of Mumbai, for public finance knowledge management for women and children, referred to as Centre of Excellence for Public Finance Management (PFM) in Maharashtra.

The Centre of Excellence for PFM in Maharashtra, is organising a **Consultative Meet on Maharashtra's Investment for Women and Children on April 25, 2023** from 10:30 am to 2:00 pm. The discussion aims to bring together economists, social activists and policy experts




