
Consolidated Feedback of Faculties for the Curriculum 2021 - 2022

The teachers of B. Com, B.M.S, B.A.F and BSc. I.T. gave their feedback on the syllabus.

On a 4-point rating scale of Excellent, Very Good, Good and Poor, 11 questions were answered and some recommendations were suggested. The analysis of the feedback given on 4 programs is as follows.

Teachers feedback for curriculum by B. Com faculties: - 98 percent of faculties found that the present syllabus being taught was up to the mark. While 2 percent teachers felt that revision in the curriculum was required. 99 percent faculty felt that they could complete syllabus on time. While 1 percent of the faculty disagreed. All the faculties felt that the aims and objectives of the syllabus were well defined and syllabi had proper balance between theory and application. All the faculties felt that the programme created interest among the students who felt that books and journals prescribed by the university were relevant and the units in the syllabus were properly sequenced and balanced. They also found that the syllabus was also industry relevant. The faculty felt that they were getting freedom to use various teaching methods. 3 percent of the faculties felt that the curriculum was getting outdated and it needed to be updated. Different recommendation & suggestions given by the faculties are as follows: -



Teachers feedback for curriculum by B.M.S. faculties: - 99 percent of the faculties felt that the syllabus taught was suitable for the programme. While 1 percent of the faculties disapproved. 98 percent of the faculties felt that they were able to complete the syllabus on time and were satisfied with the syllabus. While 2 percent of the faculties had a time constraint and felt the need to update the syllabus. All the faculties were convinced and happy to share that the objectives of the programme were well defined and were achieved through the prescribed curriculum, the flow of the syllabus was up to the mark. Faculties found that there is a balance between theory and application, students were quite interested referred the journals and reference books prescribed and it was industry oriented. All the faculties were comfortable to use various modern teaching methods while teaching. Different recommendations suggestions given by the faculties are as follows: -

Teachers feedback for curriculum by B.A.F: - 2 percent of the students have felt neither the syllabus suitable for the course nor timely completion of syllabus is possible. All the teachers felt that aims and objectives of the syllabi are well defined, course syllabi had a good balance between theory and application, relevant resource material is available to conduct the syllabus, units/ sections in the syllabi are properly sequenced and faculties were comfortable to use modern teaching tools and techniques.3 percent of the faculty felt the curriculum needed to updated as per the requirements of the Industry. Following are the Recommendation & Suggestions: -

Teachers feedback for curriculum by B.Sc.I.T: - 98 percent of faculties were satisfied with the present syllabus. While 2 percent teachers felt updating of curriculum as per the industry requirement was need of the hour. 98 percent faculty felt that they could complete syllabus on

time. While 2 percent of the faculty disagreed. All the faculties felt that the aims and objectives of the syllabus was well defined and syllabi had proper balance between theory and application. They felt that the programme created interest among the students as the books and journals prescribed by the university were relevant and the units in the syllabus were properly sequenced. They also found that the syllabus matches with the industry requirements but still few of the programming's like R Software must be added. They were comfortable using all different teaching tools and techniques. 2 percent of the faculties felt that the new concepts of the industry need to be included in the curriculum. Different recommendations& suggestions given by the faculties are as follows: -

Consolidated Feedback of Students for Curriculum 2021 - 2022

Feedback for Curriculum by B. Com Students: - The Google Form was filled by 165 First and Second year B. Com Students of theacademic year 2021 – 2022. All the students were satisfied and felt that the syllabus was fair enough to meet their demands. 99 percent of the students felt that all the teachers got enough time to cover the syllabus. But 1 percent students felt that teachers were unable to complete the entire syllabus. Other than 1 percent remaining students felt that course curriculum was fulfilling their expectations. All the students interviewed felt that the syllabus created interest and motivated them to pursue higher studies. All the students felt that various teaching methods were used by the teachers and all their queries were answered. 99 percent students felt that the assessment pattern was good and up to the mark. While, 1 percent students felt it was not satisfactory.

Feedback for Curriculum by B.M.S Students: - The Google Form was filled by 58 First and Second year BMS Students of the academic year 2021- 2022. All the students were satisfied and felt that the syllabus was fair enough to meet their demands. All the students felt that the teachers got good enough time to cover the syllabus on time. 95 percent students felt that the curriculum fulfilled the needs more than their expectations. All the students felt very motivated to pursue higher studies. All the students felt that the variety of modern teaching tools were used by teachers who also responded to their queries and problems. The assessment pattern which measured their knowledge was found by the students up to the mark.

Feedback for Curriculum by B.A.F Students: - The Google Form was filled by 42 students. 95% of the students found the syllabus very good and meeting their expectations. Not a single student reported negatively. All the students felt that faculties got enough time to cover the syllabus. Around 89 percent of the respondents found that course curriculum was fulfilling their expectations more than what they had expected. While 11 percent felt that they

didn't get what they expected. 99 percent felt that syllabus of the program gave them a direction to pursue higher studies. But I percent students didn't feel motivated. 96 percent of the students felt that teachers adopted modern teaching methods and they solved their problems. Only I percent of students felt that teachers were not using updated methods and problem were not investigated. All the students felt that the assessment pattern measured their complete knowledge and met their expectations.

Feedback for Curriculum by B.Sc.I.T. Students: - All the students felt that syllabus was fair enough to meet their demands, the teachers were getting enough time to cover the syllabus and the course curriculum also fulfilled their expectations. They all felt encouraged to pursue higher studies and a variety of teaching methods were used by the teachers. The Assessment pattern was up to the mark to judge their knowledge.
