Both parties agree to maintain confidentiality of student, institutional, financial, or proprietary information shared during the execution of this MoU.

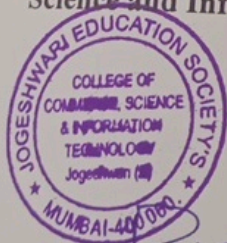
7. AMENDMENTS:
