MAGIC BUS INDIA FOUNDATION, a not-for-profit organization registered under Section 25 of the erstwhile Companies Act, 1956 (CIN: U91110MH2001NPL130853), having its registered office at Reliable Plaza, Unit No. 301, 3rd Floor, Plot No. K-10, Kalwa Industrial Area, Village Elthan, Navi Mumbai, Thane District – 400708, duly represented by **Mr. Bhaskar Lingam**, Program Manager (hereinafter referred to as “**MAGIC BUS**” or “**MBIF**”, which expression shall, unless repugnant to the context, include its executors, administrators, and assigns) as the Party of the **OTHER PART**.

JES College and Magic Bus are hereinafter collectively referred to as the “**Parties**”, and individually as a “**Party**”.

WHEREAS

a) The JES College has been actively engaged in improving education levels of youth belonging to disadvantaged and other sections of society.

b) MBIF seeks to positively impact underprivileged youth through skill development and livelihood programs, and shall provide quality training material and structured educational processes for the partnership.

Magic Bus has developed **Skill Development Courses**, including modules on **AI Fundamentals, Cyber Security, and Employability Skills**, which it delivers through its partner centers across India. Magic Bus shall also conduct **placement drives** to strengthen students’ future career prospects.

d) **The JES College** has expressed interest in conducting these training programs, as developed by Magic Bus India Foundation, at its campus for the benefit of its students.

e) This MOU expresses the intent of both Parties to collaborate under the terms described below. It is a statement of mutual understanding and does not, by itself, constitute a legally binding agreement, except as otherwise stated herein.

NOW, THEREFORE, THIS MOU WITNESSES AS UNDER:

1. NATURE OF WORK

Magic Bus shall deliver skill development courses to the students of the College as outlined in **Annexure I**. These programs aim to enhance Employability, digital literacy, and professional

readiness among students.

2. TERM

This MOU shall remain valid for a period of **24 months**, commencing from **1st December, 2025**, and may be extended upon mutual written consent of both Parties.

3. RESPONSIBILITIES OF THE PARTIES

3.1 Responsibilities of MBIF:

- i) Shortlist students based on eligibility criteria.
Conduct training sessions as per the list of courses in **Annexure I**.
- ii) Organize Career Guidance Talks / Change maker Sessions.
- iii) Provide certificates to students upon successful completion.
- iv) Conduct placement drives and provide job placement assistance to eligible students.

3.2 Responsibilities of the JES College:

- i) Share candidate details in accordance with MBIF's eligibility criteria and objectives.
- ii) Provide necessary infrastructure and facilities to conduct training sessions and related activities.

4. INTELLECTUAL PROPERTY RIGHTS

- i) All Intellectual Property Rights (IPR) owned by either Party prior to signing this MOU shall remain the sole property of that Party.
- ii) This MOU does not constitute a trademark or service mark license by either Party.
- iii) MBIF shall not use the College's logo, name, or branding without prior written consent.

5. CONFIDENTIALITY

Both Parties agree to maintain confidentiality regarding all proprietary or sensitive information exchanged under this MOU. Disclosure shall only be made as required by law or with prior written consent of the other Party.





6. INDEMNITY

Each Party agrees to indemnify and hold harmless the other Party and its representatives from

- v) **Entire Agreement:** This MOU supersedes all prior discussions and understandings regarding the subject matter.
- vi) **Severability:** If any provision is deemed invalid, the remaining provisions shall remain in effect.
- vii) **Authorization:** The signatories below represent that they are authorized to execute this MOU on behalf of their respective organizations.
