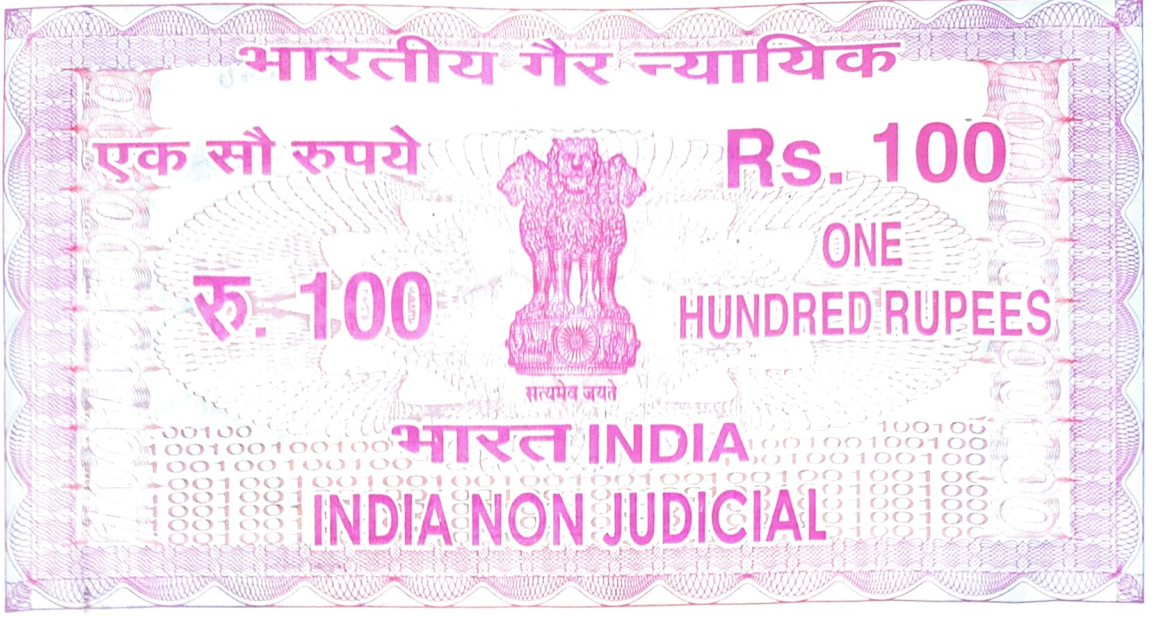

3. ROLES AND RESPONSIBILITIES

3.1 Responsibilities of the Institute:

1. Provide comprehensive BFSI training modules covering banking operations, financial services, insurance basics, compliance, customer relations, and sales skills.
2. Provide qualified trainers at the campus of the Institute.
3. Conduct assessments, evaluations, and issue certificates upon completion.
4. Offer career guidance, mock interviews, aptitude training, and soft-skills development.
5. Facilitate placement opportunities and assist in organizing placement drives

3.2 Responsibilities of the College

1. Appoint faculty coordinators for effective communication and coordination.
2. Motivate and guide students to participate in training and placement activities.

- Support scheduling, organizing, and promoting training and placement programs.

4. FINANCIAL TERMS

- The Institute will offer the course at no cost whatsoever.

5. DURATION AND RENEWAL




- This MoU is valid for **One (1) year** from the date of signing.
- It may be renewed with the written consent of both parties.
- Either party may terminate the MoU with a **30-day written notice**.

6. CONFIDENTIALITY

Both parties agree to maintain confidentiality of student, institutional, financial, or proprietary information shared during the execution of this MoU.

8. AMENDMENTS

Amendments to this MoU must be made in writing and signed by authorized representatives of both parties.
