ELIGIBILITY FOR ADMISSION

A candidate seeking admission to the three year degree course of the Bachelor of Commerce or Bachelor of Science in IT must have passed H.S.C (Std. XII) examination conducted by any Divisional Board of the Maharashtra State Board of Secondary and Higher Secondary Education.

OR

Must have passed the Higher Secondary School Certificate (Std. XII) examination with vocational subjects / minimum competency based vocational course conducted by the different Divisional Boards of the Maharashtra State Board of Secondary and Higher Secondary Education.

OR

Must have passed the examination of any other Board or Body recognized as equivalent to Higher Secondary School Certificate (Std. XII) Examination conducted by other states.

ADMISSION PROCEDURE

1. University of Mumbai Pre Registration form 2026-2027 must be filled in:
<https://muugadmission.samarth.edu.in>

JES College of Commerce Science and IT with the College Code 956 to be selected. Take the hard copy / soft copy of the pre-registration form 2026-27 and keep it ready before you proceed.

2. Students are required to fill in the College Admission Form and select the subjects or group of subjects as per their choice; the details of which are given in the College Prospectus. Students must affix 2 (Two) photographs on the College Admission Form in the boxes provided.
3. Students must apply separately for each course, if he/she desires.
4. Pre-admission: Students must submit the following in the College Office

(a). The Pre-Admission Enrolment form must be downloaded from the University Website; Duly Filled and Submitted
and

(b) The College Admission Form Must be Duly Filled in He /She will receive token/ receipt, which will be required for confirming his/her Admission after the Merit List.

Note: No Originals or photocopies of documents need to be submitted at this stage.

5. Merit lists will be put up and displayed by the College as per the University of Mumbai schedule
6. Admission Confirmation: Once student's name appears in the College merit list, he/she must immediately contact the College office to confirm the admission. For this, he/she must carry-

(a). Admission Token / Receipt;

(b). Original documents with the required number of photocopies; and

(c). Demand Draft favouring “JES College of Commerce, Science and IT” as per the fee structure of the course; details of which are given in the College Prospectus.

7. On verification by the Admission Committee, the student should pay the required amount of fees in the Accounts Office and collect the Fee Receipt as confirmation of admission. The original Fee Receipt must be carefully preserved.

8. If a student fails to confirm his/her admission as stated above, his/her name will not be considered in the subsequent merit lists.

Important: All admissions are provisional and done strictly on merit basis. Admission is confirmed on the basis of submission of original documents, scrutiny and approval of Admission Committee and payment of fee as mentioned.

Note: The Admission Forms for FY Programmes in JES College of Commerce, Science and Information Technology and the Prospectus are also available in the College Website for reference. Hard copy of the same will be during pre-admission.

- Provisional Eligibility Certificate (Applicable only for students from other than Maharashtra State Board)
- Migration Certificate (Applicable only for students from other than Maharashtra State Board)
- One self-attested photocopy each, of Aadhaar card and PAN Card.
- Two passport size photographs of the student (Frontal view of the face against white background)
- GAP Certificate (Joint Affidavit) of the student and either of the parents on a Rs 100/- stamp paper, if there is a break of more than a year in the academic career after passing Std XII (draft of GAP Certificate will be provided).

Important note:

- 1.The right of making subject combinations and the choice of electives mentioned in all faculties is vested with the principal, depending upon the demand of subjects and electives from students.
- 2.The number of seats for different subjects and elective combination will be decided by the principal.
- 3.Subject(s) and elective(s), which do not have the minimum enrolment required by the Government/University, will not be offered.
- 4.Examination of Semester I, II, III & IV will be conducted by the college on Behalf of the University of Mumbai as per the University schedule, rules, regulations and guidelines, while examinations of Semester V & VI will be conducted by the University of Mumbai.

DISCIPLINARY RULES AND REGULATION

Students joining the College must strictly abide by the Rules and Regulations of the College.

- 1.Every student must wear the Identity Card with his / her Photograph attested and basic personal information with Blood Group if he / she is in the College premises.

A reference is invited to the Ordinance relating to the Refund of fees vide this office Circular No.UG/257 of 2005 dated 1st July,2005 and the Principals of the affiliated colleges and the Heads/Directors of the recognized Institutions concerned are hereby informed that the proposal submitted by the committee for amendment of O.2859 relating to the refund of Tuition Fees, Development and all other fees after cancellation of admission for the Under-Graduate Courses has been accepted by the Academic Council at its meeting held on 13th June,2008 vide Item No.76 and subsequently approved by the Management Council at its meeting held on 2nd July,2008 vide item No.6 and that, in accordance therewith, in exercise of the powers conferred upon the Management Council under Section 54(1) of the Maharashtra Universities Act,1994, it has amended Ordinance 2859 relating to refund of fees to read as under :-

REFUND OF FEES

O.2859: Refund of Tuition, Development and all other fees after cancellation of admissions:

The candidates who have taken admission in under graduate courses in Govt. colleges, in Govt. aided and unaided courses conducted by affiliated colleges, and recognized Institutions may request for refund of fees after applying in writing for cancellation of their admission to the course. The refund of fees as applicable shall be made on or before 30th day after the date of cancellation and thereafter. The percentage of fee for the course shall be refunded to the candidate after deducting charges as follows:

NOTE: The total amount considered for the refund of fees from the commencement of academic term of the courses includes the following:-

- All the fee items chargeable for one year are as per relevant University circulars for different Faculties (excluding the courses for which the total amount is fixed by other competent authorities).

- ii) The Fee charged towards group insurance and all fee components to be paid as University share (including Vice-Chancellor fund, University fee for sports and cultural activities, E-charge, disaster management fund, exam. fee and Enrollment fee) are non-refundable if payment is made by the college prior to the date of cancellation.
- iii) Fee collected for Identity card and Library card, admission form and prospectus, enrollment and any other course specific fee **are not refundable** after the commencement of the academic term.
- iv) All refundable deposits (Laboratory, Caution Money and Library etc.) **shall be fully returned** at the time of cancellation.

Provided that wherever admissions are made through centralized admission process for professional and/ or for any other courses by other competent Authorities, the Refund Rules are applicable if specified by such authorities (as per the rules of relevant agencies) for the 1st year admission. In case of admission to subsequent years of the course, O.2859 is applicable for cancellation of admission.

Provided further that this refund rule is concurrent with the rules and guidelines of other professional statutory bodies appointed for admission for relevant courses.

Further that O.2859-A & O.2859-B have been repealed and the amended O.2859 relating to the refund of Tuition Fees, Development and all other fees after cancellation of admission for the Under Graduate Courses has been brought into force with effect from the academic year 2008-2009.

Subject: Fee Refund Policy 2024-25

आदरणीय महोदय/महोदय,

The University Grants Commission receives many representations/complaints from students/parents on the non-refund of fees by the Higher Education Institutions (HEIs) on cancellation/withdrawal of admissions.

2. Students should be allowed a full refund of fees within a specified period to enable them to opt for a course of their choice.

3. The Commission has considered the matter in its 580th meeting held on 15 May 2024, and after considering the relevant factors decided, the following fee refund policy for the academic session 2024-25:

- Notwithstanding anything contained in any guidelines/ prospectus/ notification/ schedule, a full refund of fees shall be made by the HEIs on account of all cancellations of admissions/migrations of students up to 30 September 2024 and with a deduction of not more than Rs. 1,000, as a processing fee, up to 31 October 2024.
- It shall apply to all higher education institutions, whether established or incorporated by or under a Central Act or a State Act, and every institution recognized by the University Grants Commission under clause (f) of Section 2 of the University Grants Commission Act, 1956 and to all institutions deemed to be a University declared as such under Section 3 therein and to all higher education institutions affiliated to a University.
- These guidelines would also be applicable to organizations, consortiums, committees, associations, etc., constituted for the purpose of conducting counselling or processing admissions and collecting fees on behalf of participating HEIs, and the HEI concerned will be responsible for refund fees.
- For any admission schedule extending/commencing beyond/after 31 October 2024, the provisions contained in the UGC Notification issued in October 2018 on Refund of Fees and Non-Retention of Original Certificates shall apply (reproduced below for ready reference):

Category	Percentage of Refund of fees*	Point of time when notice of withdrawal of admission is received in the HEI
(1)	100%	15 days or more before the formally notified last date of admission
(2)	90%	Less than 15 days before the formally notified last date of admission
(3)	80%	15 days or less after the formally notified last date of admission
(4)	50%	30 days or less, but more than 15 days after formally notified last date of admission
(5)	00%	More than 30 days after formally notified last date of admission

- e. This policy will remain in force for subsequent academic sessions until the issuance of a revised policy by the UGC.

4. It may also be noted that the UGC has notified the Redressal of Grievances of Students Regulations, 2023, wherein "delay in, or denial of, the refund of fees due to a student who withdraws admission within the time mentioned in the prospectus, subject to guidelines, if any, issued by the Commission, from time to time" has been defined as one of the grievances.

5. The Higher Education Institutions are requested to ensure compliance with the fee refund policy for the academic session 2024-25 and redress any grievance by the provisions of the University Grants Commission (Redressal of Grievances of Students) Regulations, 2023.

6. Any HEI violating the provisions of UGC Fee Refund Policy 2024-25 shall be liable for punitive action as notified in Clause 5 of the UGC Notification on Refund of Fees and Non-Retention of Original Certificates issued in October 2018.
